

In the Name of God Amen,

I Joseph Reynolds of Bristol in the County of Bristol in the State of Rhode Island & Providence Plantations: labouring under some indisposition of body, but of a sound & disposing mind & memory, for which I acknowledge Divine Goodness, & calling to mind that it is appointed unto all men once to die, do make this my last Will and Testament as follows viz -

Firstly - I Give & recommend my Soul unto God who gave it, through the merits of a glorious Redeemer, and my Body to be decently buried by my Executor hereafter named, in hopes of a Glorious Resurrection into Eternal life, & as touching the Worldly Estate Where with it hath pleased God to bless me (after the payment of my just Debts & funeral Expences) I give and dispose of as follows: - -

Firstly - I Give and bequeath to my beloved Wife, Sarah Reynolds, in addition to her right of Dower in & to my Estate, all my house hold furniture together with my Chaise, one Cow, & half the Interest arising from my Stock in the Commercial Bank in Bristol, the said furniture, Chaise and Cow to be at her disposal- and the said interest to be by her enjoyed during the term of her natural life - -

Secondly - I Give and Devise to my beloved Son William Reynolds, to him his heirs, and Assigns forever, one tract or piece of land lying in sd Bristol and described as follows, viz: Beginning at the North West of a lot of land belonging to Jonathan Fales, thence running Northerly, Eight Rods, bounding Westerly on the Country Road, leading from the Compact part of the Town of Bristol to Warren- Thence turning and running Easterly, Seventy two Rods to a Stone Wall, thence turning & running Southerly, Eight Rods, to land of said Fales, bounding Easterly by said Wall; thence turning Westerly Seventy two Rods, to the first mentioned Corner, hereby including in these boundaries the lot of land conveyed by me to my said Son, whereon his House now stands, as by my deed to him for description will appear - -

Thirdly - I Give Devise & bequeath to my beloved Son Greenwood Reynolds, to him his heirs & Assigns forever all the land lying between that devised to my said Son William Reynolds extending Northerly on the on the Country Road leading to Warren- till it meets the South line of of land belonging to my Brother Samuel Reynolds, thence Running Easterly to the Eastern boundary of the land devised to my said Son William bounding Northerly on the South line of my said Brother Samuel's land together with all the buildings thereon standing, including the one undivided half of the grist mill & the privileges & appurtenances & the undivided half of all the lands thereunto belonging- likewise I give & bequeath to my said Son Greenwood Reynolds all my farming Utensils of every description - -

Fourthly - I Give and bequeath to my Daughter Phebe Reynold the use & Occupation of the West Room on the lower floor & the Sleeping Room Chamber, so long as she in her own proper Person shall wish to occupy the same, likewise my ten shares in the Commercial Bank deducting the one half of the interest bequested to her mother Sarah Reynolds likewise a Privilege in the Cellar for Keeping Sauce and a Privilege and a Privilege in the Well & Aqueduct

Fifthly - I Give and bequeath to my beloved Grandson Joseph Reynolds son of Greenwood Reynolds my Silver Tankard after the decease of my Wife. -

Sixthly - I Give and bequeath to my beloved Daughter Phebe Reynolds all the Household furniture not disposed of by my Wife at the time of her decease -

Seventhly - I Give and bequeath to my beloved Sons William Reynolds & Greenwood Reynolds all my Wearing Apparel which I may leave at the time of my decease - -

Eighthly - I Give & Devise to my Children viz William Reynolds Greenwood Reynolds, Sarah Bradford wife of Daniel Bradford Ann Peck wife of John Peck, Phebe Reynolds, Elizabeth Bradford wife of Samuel Bradford & Hannah Burgess wife of James P Burgess all the rest & residue of my Real Estate lying Eastward of that devised to my two Sons William Reynolds and Greenwood Reynolds to them their Heirs & Assigns forever Share & Share alike

Ninthly - all the rest of my Estate not heretofore disposed of I Give and bequeath to my beloved Sons William Reynolds & Greenwood Reynolds to be equally divided between them

Lastly - I hereby nominate, constitute & appoint my Beloved Sons William Reynolds & Greenwood Reynolds, Executors of this my last Will & Testament; hereby revoking & annulling all Other & former Wills by me made & establishing this & this only as my last Will & Testament -
